75,000 Strong and Counting... to 250,000

Over the past several months you may have noticed that we, CARENET AmeriCorps, have been making an effort to increase our visible presence throughout the Adams 14 community. If you have noticed it in no other regard, you're reading this newsletter, aren't you?

What you may not know is that CARENET is not the only AmeriCorps presence among you. No joke- other AmeriCorps programs serve Commerce City, as well, simply in different capacities! All of the regional Salud clinics receive the services of a health-based AmeriCorps program. A Youth Corps team has invested numerous hours eradicating invasive species out at the Rocky Mountain Arsenal National Wildlife Refuge. If you expand your search to the Denver metro area, you will find 14 different AmeriCorps programs with another 2 dozen spread

throughout the state! These programs engage several hundred AmeriCorps members in dozens of different civically responsible and necessary roles.

To paint an even broader picture, an open search of ALL AmeriCorps postings yields 5,490 results. Most of those postings likely are recruiting for anywhere from 1 –20 members or more! The positions are located throughout all 50 states, Washington D.C., American Samoa, Guam, Saipan, Puerto Rico, and the Virgin Islands. (Service in St. Croix, anyone?)

All told, approximately 75,000 U.S. citizens already are actively serving their country through Ameri-Corps. You might like to know that it has been President Obama's intent since early in his campaign to expand the program to 250,000 members by 2017. As a first step in that direction, the American Recovery and Re-



investment Act of 2009 includes \$201 million for the Corporation for National and Community Service, the parent organization for Ameri-Corps. This marks the first federal legislative update and expansion AmeriCorps has experienced in its 15-year life.

An additional aspiration of the new administration is the development of a National Reserve Service Corps, which will recruit and train AmeriCorps alumni to deploy and serve in the event

The Recovery Act for National and Community Service

On February 17th, 2009, President Barack Obama signed into law the much needed and highly anticipated American Recovery and Reinvestment Act of 2009 (Recovery Act). Never, in the annals of American history has there been a bolder or more unprecedented legislative measure enacted than this one. Not since the actions of President Franklin Delano Roosevelt, with the creation of the New Deal during the Great Depression, has it been necessary for the government to step in on such enormous levels. While many people feel that this piece of legislation is an overstepping of our government, we are definitely caught in a tight spot right now and I for one feel comforted by the fact that millions of dollars have

been allotted for specific actions that will jump-start the economy, create and save many jobs shore side, move us towards energy independence and improve affordable healthcare—and that is just to name a few.

I also feel comforted by the fact that within this act, \$201 million in funding has been set aside for the Corporation for National and Community Service to support an expansion of AmeriCorps State and National, and AmeriCorps VISTA programs. nities, such as health and medical support, educational advancement, environmental upkeep, and disaster relief. We need to open our eyes, and help each other grow, in order for our nation to grow. As far as service goes, this act can bring great change!
